What is Shepherd's Run Solar?


Proposed 60 MW industrial scale solar energy project

- Will fill a whole valley in Craryville, Town of Copake
- 220,000 motor-driven solar panels on 265 acres
- Private developer, Hecate, owned 40% by Repsol (Spain's national oil co.)
- Removes prime farmland from use, clears 40 acres of forest
- Sits on top of City of Hudson's source of drinking water
- Sited on 21 wetlands, 9 protected streams
- Abuts Taconic Hills School, Copake Lake, Rheinstrom Audubon Sanctuary



What is Shepherd's Run Solar?

- Sprawling footprint
- 7 separate solar fields
- Next to 100 homes & businesses
- Taconic Hills School campus
- 10 historic properties,
 4 National Register eligible with Adverse Impact
 Determination
- Revolutionary War cemetery
- Mohican historic site
 Sensible Solar for Rural New York



What's Wrong with Shepherd's Run

No Benefits/Only Negatives

- No jobs
- Tax breaks reduce local revenues a State give-away to developers.
- Di minimis electricity bill reductions
- Property values go down
- Violates town zoning and local laws
- Hurts local economy which depends or agriculture & tourism

What's Wrong with Shepherd's Run, continued

No Benefits/Only Negatives

- Removes hundreds of acres of farmland
- Drills under wetlands and streams for electrical cables
- Cuts 40 acres of trees
- Soil erosion, water run-off
- Disturbs wildlife habitat and key migration paths
- Noise -during 1 year construction, and during operation
- Changes scenic views forever




Dangers to Water

NYS One-Sided Permitting Process ("94-c")

Accelerated Renewable Energy and Community Benefit Act


- Created in 2020 as part of budget
- Private developer friendly rules written by industry lobbyist
- Created Office of Renewable Energy Siting ("ORES") reporting to Governor
- ORES can overrule Town & County laws ignores "Home Rule"
- Taxes are charged based on State formulas
- ORES not required to reply or respond to any public input
- "Fast track" process



Concerns are Mounting

Issues have not been addressed

- Resolutions of Columbia County, Hudson, Copake, Hillsdale, Taghkanic and Claverack oppose this project as it stands now
- Water quality is threatened. Taghkanic Headwaters
 Conservation Plan has not been addressed or considered
- Developer plans to sell out, so who will be responsible?
- End of project life what happens?
- A lasting negative impact on the environment





Where We Stand

Shepherd's Run is ill-conceived

We stand with the Town of Copake and oppose Shepherd's Run as proposed because:

- It's enormous.
- It's poorly sited.
- It overrides "Home Rule" and Town authority
- Conflicts with our community determined goals and objectives set forth in Copake's conservation plans of 2005, 2011, 2014 and 2022
- Industrialization of our rural landscape = net loss to us.
- No benefits/only negatives.
- Profits generated to Hecate will leave the community.



What Needs to Happen



- NYS must honor Home Rule, respect upstate Towns' priorities
- Permit application <u>process is flawed</u>, and must be changed
- ORES having sole authority is problematic
- More emphasis is needed on <u>community protection</u>; the governing law is the Climate Leadership and Community Protection Act
- NYS must create a <u>state-wide **Master Siting Plan**</u> that protects farmland, water, historic properties & neighborhoods from bad developments
- Stay informed. Stand with <u>local leaders</u>, not Albany
- Must voice our concerns to political representatives and to ORES
- Awaiting ORES response expected week of 3/27/23
